Euronext and the three interoperable CCPs for Oslo Børs – EuroCCP, LCH Ltd and SIX x-clear – will extend trading and clearing permissions at the same time to all participants on the Euronext Growth Oslo Market, for all Euronext Growth Oslo Market securities.

Access to EGO will be granted to all existing Oslo Børs members with access to the Securities market as of the given production date. Please contact our membership team (euronextmembership@euronext.com) in case you prefer to opt out for this additional access.

The EUA platform will be made available for testing with all three CCPs at the same time as indicated below. Member conformance testing is not mandatory; however, Euronext's Operational Client Services Desk remains available to support members if they would like to perform end-to-end testing.
